

St Bart's provides short to medium-term accommodation for adults with persistent mental health challenges who are experiencing or at risk of homelessness. We provide this recovery focused and trauma-informed service at our onsite supported Community Recovery Villages and Accommodation Units.

Before completing a referral we recommend reading the below information and completing our "Pre-Referral Screening Tool". This guide is designed to support Referrers in assessing whether St Bart's Mental Health Supported Services are able to safely and effectively support the applicant.

We only accept referrals when we have vacancies within our services.

MENTAL HEALTH SUPPORTED ACCOMMODATION

Community Recovery Villages [CRV]

We have four CRVs located across Perth, which are medium term residential supported accommodations for adults living with a mental illness. Residents in our CRVs can stay for up to three years. The accommodation is for people who need two to four hours of support per day in order to live independently in the community. This service is a community based, home-like environment, with 24/7 support available.

Accommodation consists of fully furnished and self-contained one, two or three bedroom units, each with shared living areas. Each bedroom has their own bathroom.

Locations are in Kelmscott (Arnott CRV), Bentley, Stirling (Sunflower CRV) & Middle Swan (Swan CRV)

Who is eligible?

- Must be linked with a community mental health team for case management and clinical support.
- Be aged over 18.
- Be living with a mental health challenge.
- Be homeless or at risk of homelessness.
- Have low to medium support needs of between 2 – 4 hours per day.
- Be able to live independently and willing to live in a shared environment.
- Currently residing in Western Australia.
- A Permanent Resident or Citizen of Australia.
- Currently receiving or entitled to an income such as Centrelink or a regular wage.
- Be prepared to sign an Individual Recovery Agreement and identify and work towards your goals including longer-term accommodation

Accommodation Units [AU]

We have three AUs located across Perth, which are short term, community based transitional or respite supported accommodations for adults living with a mental illness who need two to four hours of support per day in order to live independently in the community. This service does not provide 24/7 support. Consumers in our AUs can stay for up to 12 months.

Accommodation consists of two fully furnished and self-contained three bedroom units with shared bathroom and living facilities.

Locations are in Cannington, Medina & Midland.

Who is eligible?

- You must be linked with a community mental health team for case management and clinical support.
- Be aged over 18.
- Be living with a mental health challenge.
- Be homeless or at risk of homelessness.
- Have low to medium support needs of between 2 – 4 hours per day.
- Be able to live independently and willing to live in a shared environment.
- Currently residing in Western Australia.
- A Permanent Resident or Citizen of Australia.
- Currently receiving or entitled to an income such as Centrelink or a regular wage.
- Be prepared to sign an Individual Recovery Agreement and identify and work towards your goals including longer-term accommodation.

Please note, we review all referrals for all of our services case by case and assess if we are able to support the person's needs in our service.
